a) BIX fees in HUF

BIX service basic fee: 135 000 HUF / year

The BIX service basic fee is payable in advance for each item year. New BIX Members, if they join in the second half of the year, only a half-year basic fee will be charged in the item year.

Notes:

- (1) On the bandwidth limited ports (1/10G, 4/10G, 10/100G and 40/100G) the total bandwidth is available. The usage of the port is evaluated based on the 95% utilization rate rule, according to the industrial norm. See the details in paragraph 5. e) of the BIX Charter annex of the General Terms and Conditions. In the case the port utilization is over the limit, then +10% surcharge shall be applied, unless the BIX member has only one active 1/10G or 4/10G port at any Budapest BIX nodes, where the 10% surcharge shall not be applied. In case of 10/100G ports, if the port utilisation exceeds 10Gbps, but stays below 40Gbps, then extra 175 000 Ft / 500 EUR shall be payed, if exceeds the 40Gbps limit, then further 175 000 Ft / 500 EUR surcharge fee shall be paid in the given month (exactly the same rule applies for the overutilization of a 40/100G port).

Promotions:

- (2) Only on Budapest nodes for the first 1 Gbps open-peering port **up to 2Gbps utilization** no monthly fee applies if the BIX member has no additional ports. In case of overutilization between 2Gbps and 3Gbps HUF 60 000 / 200 EUR monthly fee shall be paid. Above 3Gbps 20 000 Ft / 60 EUR per Gbps will be charged in the given month.
- (3) The one-time fee of the 1st and the 2nd 100G active port shall be waived, otherwise the one-time fee will be equal to the monthly fee for the active 100G BIX port.

Discounted prices for reserve ports:

Discounts of reserve ports are 75% of the monthly active port fee! See the details in paragraph 5. e) of the BIX Charter annex of the General Terms and Conditions.

Suspended ports:

The monthly fee of suspended ports are 20% of the active port monthly fee!
